The Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) to provide the e-voting facility on <http://www.evotingindia.co.in>. Kindly refer to the Notice of AGM sent to the members with regards to e-voting. The e-voting on the resolution to be passed at the said AGM of the Company shall begin on Wednesday 17th 2014 (9.00 a.m.) to Friday September 19, 2014 (6.00 p.m.). During this period the Shareholders of the Company, holding shares either in physical form or in dematerialized form, as on cut-off date i.e. 22nd August, 2014, may cast their votes electronically. The e-voting shall not be allowed beyond the said date and time. The Company has appointed Mr. Suhas Ganpule, Practicing Company Secretary (C.P. No. 5722) to act as scrutinizer for conducting the electronic voting process in a fair and transparent manner.
