Ahmedabad : The police on Wednesday seized liquor stock from a boat in Narmada River in Kevadia. The liquor stock was being smuggled into the state either via Madhya Pradesh or Maharashtra. HC grants bail in NDPS case

Ahmedabad: The Gujarat high court on Wednesday granted bail to one Gajanan Goswami who was arrested along with others from Mahuva in Bhavnagar district in connection with seizure of 1,371 kg of poppy straw in June 2020. Poppy straw weighing 1,371 kg was found in 69 bags, of which 62 were recovered from a truck and

seven bags were found from an agriculture field. Goswami and other accused were arrested and booked under the Narcotic Drugs and Psychotropic Substances Act.

BJP leader, wife were killed by farmer over Rs 20,000 dispute in Mahisagar



Ahmedabad : A dispute over merely Rs 20,000 has emerged as the reason for the brutal murder of veteran BJP member from Mahisagar and his wife who were hacked to death on the night of August 4.

Cracking the case, Mahisagar police arrested Bhikha Patel, who was known to the deceased Tribhuvandas Panchal. Cops zeroed in on Patel after checking the details of Panchal's call records which revealed that he had been repeatedly speaking to Patel a day before the murder. Panchal, who was

Deputy superintendent of police, NV Patel, said that with no valuables or cash missing, it was evident that robbery was not the motive. It had also become clear that the murderer may have been known to Panchal as he had gone into the courtyard and opened the gate at the back of the house. He got even when he was having dinner as food was found on his hand.

A key of the rear gate was also found near the body, indicating that he had opened the gate. This gate was not used commonly except at times when Panchal wanted to go to buy milk. The couple and others used the front entrance of the house.

Information gathered by the police also revealed that there were some financial dealings between Panchal and Bhikha. Police investigated Patel who confessed to the crime and led the police to the murder weapon and Panchal's phone too.

Patel said he killed Panchal's wife too as she had witnessed the murder.

Four booked for abetting their biz partner's suicide

Ahmedabad : Four persons including three women were booked for abetting the suicide of a 35-year-old woman who ended her life in Rajkot city.

Deviben Rathod, a resident of Bhavnagar, had hanged herself to death at her residence allegedly after she got cheated by her own partners. Hashma Kasmani, Shabana, Naban Chaudhari and Chetan Bhatti—who have been booked for abetting for suicide. Police have arrested Bhatti but yet to arrest the three women.

According to the complaint filed by Deviben's mother Ranjan Rathod (60), her daughter used to run a chit fund type scheme along with the four accused where they collected small amounts from members. A few months ago, Hashma, Shabana and Naban refused to provide details of money collected from the members.

Deviben was under stress as the members who had

invested in the scheme were calling her and demanding their money back. Ranjan came to know about this alleged cheating after hearing audio recording of Deviben's conversation on mobile phone with the accused.

Police estimate that about Rs 11 crore of people's money was involved. Not being able

to pay the investors took a toll on Deviben's mental health and she ended her life on June 1. Police said that Deviben had divorced her husband and was living with her mother.

"Deviben was reportedly in love with Bhatti who also pawned her jewellery and took the money," alleged Ranjan in her complaint.

Gujarat reports 21 cases in 24 hours, all in 6 districts

Gandhinagar: Gujarat reported 21 fresh cases of Covid-19 in 24 hours ending Tuesday evening, as per the bulletin issued by the state health department. No death was reported during this period. The active caseload of Covid-19 in the state is 205, of which 4 patients are on ventilator, while the remaining 202 are in a stable condition.

The 21 cases that were reported on Tuesday are all distributed across 6 districts of the state. Ahmedabad city reported 7 cases, Surat city had 5 and rural had 2. Rajkot rural and city reported 2 and 1 cases respectively, Vadodra city had 2 cases, Jamnagar city and Kheda reported 1 case each, a case was reported from any other district.

As many as 24 patients recovered from Covid-19 on Tuesday. The overall recovery is 8,13,802, which is 98.75 per cent of the total cases.
